The scope is defined as Cradle-to-gate, analyzing the carbon footprint and environmental impacts of products using Wistron's PCF/LCA system.

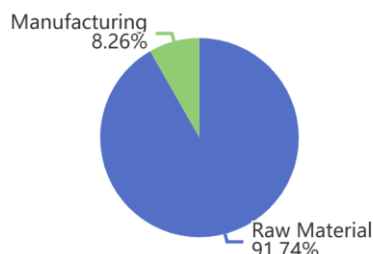
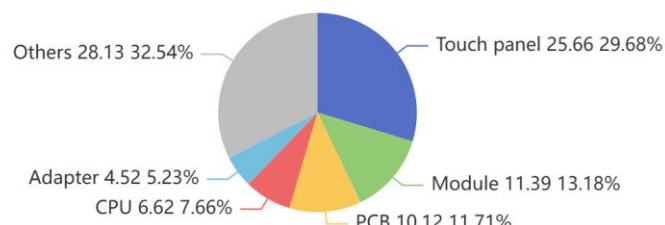


Figure 2. Hotspot Analysis of Raw Material [Component Category]

- ◆ Figure 1. Product Carbon Footprint Calculation Results - The calculation follows the IPCC 2021 GWP100a v1.03 methodology. The total carbon emissions amount to 93.51 kgCO₂ eq. This result provides insights into the distribution of carbon emissions across various product life cycle stages.
- ◆ Figure 2: Hotspot Analysis of Raw Material Acquisition Phase - Further analysis identifies raw materials with higher carbon emissions, serving as a reference for future carbon reduction strategies for products.

The environmental impact assessment adopts the Environmental Footprint v.3.1 methodology to analyze the environmental impacts of various stages in the product life cycle. The results of the assessment are detailed in the following table:
